REQUEST FOR EXTENSION OF TIME TO FILE AN ANSWER

NOW COMES the Commonwealth of Pennsylvania, Gaming Control Board ("Board"), Bureau of Investigations and Enforcement by and through the Office of Enforcement Counsel and files this Request for Extension of Time to File an Answer and states the following:

- On August 29, 2024, Integrity Compliance 360 Inc. ("IC360") filed a Letter with the Board's Office of Hearings and Appeals ("OHA") notifying the Board of Matthew Holt's resignation from his position as Chief Executive Officer and Director of IC360.
 Matthew Holt holds a Qualification, as approved by the Board on October 13, 2021.
- 2. The Office of Enforcement Counsel's Answer is due on September 30, 2024.
- 3. The Bureau of Investigations and Enforcement will be launching a full investigation into the matter.
- 4. The Office of Enforcement Counsel will require the results of the investigation before an informed Answer to the Petition can be made.
- 5. The Office of Enforcement Counsel requests an additional sixty (60) days to review the Petition and the results of the Bureau of Investigations and Enforcement investigation before responding to the matter.

6. Petitioner, through counsel, has communicated to the Office of Enforcement Counsel

that there is no objection to the instant Request for Extension of Time to File an

Answer.

7. Pursuant to 58 Pa. Code § 493a.8(a), "A motion may be made at any time after the

initiation of a proceeding for procedural relief including a request for an extension of

time, a continuance of a hearing or other scheduled proceeding, or a request for a

prehearing conference."

WHEREFORE, the Office of Enforcement Counsel requests an additional sixty (60) days to

file an Answer in the above captioned matter and that the new due date for the Answer be

December 2, 2024.
